This series is divided into the following subseries: 1. Background files, 1956-1960;

2. Circuit court files, 1960-1961; 3. Alabama Supreme Court files, 1961-1962; 4. United States Supreme Court files, 1961-1963; and 5. Law notes, 1957-1962.

### 1. Background files, 1956-1960

This subseries includes copies of the *New York Times* advertisement that started the original lawsuit, as well as some negative correspondence that was written to Police Commissioner L. B. Sullvan after the ad ran. A folder labeled background information includes a letter to Franklin W. Parks from the firm of Lord, Day and Lord; minutes of the Alabama State Board of Education and other documents concerning the expulsion of students from Alabama State College; and a photo of officials investigating dynamite left on the porch of Martin Luther King, Jr.'s house. Photocopies of Martin Luther King Jr.'s driver's record, 1956-1959, are also included in this subseries.

### 2. Circuit court files, 1960-1961

This subseries is composed of documents created during the phase of the trial when it was in the 15<sup>th</sup> Judicial Circuit Court in Montgomery, Ala. It includes court documents such as subpoenas; motions; orders and opinions; interrogatories; objections to interrogatories; deposition notices; replies to objections; court rulings; petitions for writ of mandamus; memoranda; outline of proof documents; and copies of a motion for a new trial. Notes made to files include handwritten notes on questions given to jurors; notes about the New York Times and its staff; and a list of news articles and ads referencing Alabama that ran in the New York Times from 1956 to 1960. The subseries also contains correspondence and notices of garnishment given to the defendants after they lost the case.

The subseries also includes some court documents from *Eugene Connor vs. New York Times*, such as interrogatories to defendants and answers to interrogatories.

#### SERIES D. CORRESPONDENCE, 1960-1970

This series is composed of correspondence resulting from and regarding *New York Times vs. Sullivan*. Much of it is routine correspondence, such as letters requesting copies of court documents. There are also letters from attorneys in and out of the state of Alabama, requesting information about the case and letters written by Nachman to other attorneys requesting information about other libel cases. Correspondence worth noting includes a letter from the Mobile County sheriff regarding the planned sale of J. E. Lowery's property resulting from the *Times vs. Sullivan* case; a letter from the Alabama attorney general's office written 29 June 1960 giving and requesting information about the case; and a 1962 press release and brochure from the Lawyers Committee on the Alabama Libel Suits. Some of the letters contain financial requisitions, receipts, and clippings.

#### SERIES F. CLIPPINGS AND NEWSPAPERS, 1954-1964, undated

This series is composed mainly of clippings, but also includes some issues of the *New York Times*. Clippings document the events surrounding the *Times vs. Sullivan* case, as well as opinions about it. The clippings also give information about related cases; libel lawsuits; libel laws; the civil rights movement; public opinion about the civil rights movement; the response of different churches to civil disobedience; opinions about a newspaper's responsibility in accurate reporting; and racial tension in the south. Some newspapers represented in the series include the *Birmingham News*, the *Montgomery Advertiser*, the *New York Times*, the *Alabama Journal*, and the *Birmingham Post-Herald*,
